#### **Job Essential Functions**

Under the direction of and in collaboration with the Manager of English Learner & Academic Support Programs the Ethnic Studies (ETHS) Coordinator will:

- 1. Support the continuous updating and submission of current Ethnic Studies (ETHS) courses of studies
- 2. Support the development and submission of new Ethnic Studies (ETHS) courses of studies as needed
- 3. Curate model lessons and collect resources for established units of study; including vetting new materials
- 4. Coach, support, and mentor Ethnic Studies teachers; with a focus on teachers teaching ETHS for the first time
- 5. Conduct classroom observations/learning walks
- 6. Help plan and organize ETHS professional development
- 7. Oversee the implementation of semester ETHS student surveys and develop executive summaries of the results
